The goal of Camp Spotlight with Stepp Stewart is to get the most out of its campers so that they can give the most to their audience. Stepp Stewart and his Dynamite staff bring their professional expertise and knowledge to the camp while allowing the campers to discover and develop their own talents. Past campers have had the opportunity to perform and work with superstars like Chris Tucker and participated in private workshops with stars from Broadway's "Hamilton", "In the Heights" and "Tina". They have participated in one-on-one talkback sessions with international recording artist Cece Peniston and were granted a private tour of Black Hall Studios. ENROLLMENT CONTRACT FEE POLICY

Registration fee is **\$150** and is in addition to the camp tuition fee of **\$600.00**.

Registration Fee. The Registration fee of \$150 covers camp supplies, photo session, one (1) camp t-shirt and one (1) Performance t-shirt.

Extra camp t-shirts are \$15.00 each.

Paid registration fees are non-refundable.

Tuition Fee. Tuition fee of \$600 is due in full by **May 1st**. **Registration will be closed once we reach the maximum number of campers that have paid in full.**

Early Bird Discount – Tuition is \$550 if paid by March 29, 2024.

Late Pick-up Fee. Camp ends at 3:00 p.m. daily. There is an additional \$1.00 per minute charge for late pick-up unless you have made aftercare arrangements with the camp. Aftercare fees are \$15.00 a day or \$50.00 for the week per camper and all campers in aftercare must be picked up no later than 4:30 p.m. All other campers must be picked up by 3:00 p.m.

Returned Check Fee. All checks returned due to insufficient funds will be charged \$35.00 and must be exchanged with cash, money order or debit card payment. Returned checks will not be re-deposited and must be paid immediately or the child will be officially withdrawn. Checks must be made payable to: **Stage Door Miracles, Inc.**
